Mediterranean Strategy for Sustainable Development 2016-2025 (MSSD 2016-2025): Implementation and Monitoring Plan

Introduction

1. The main purpose of this document is to present in a concise form, focused on the Targets and Flagship Initiatives, the actions stemming from the Mediterranean Strategy for Sustainable Development 2016-2025 (MSSD 2016-2025) and to propose the main elements of the work plan for the implementation and monitoring of the MSSD 2016-2025. The Steering Committee of the Mediterranean Commission on Sustainable Development (MCSD) is invited to review and discuss the work plan (as contained in Table 3 including the owners/actors and timeline, and taking into consideration the necessary resources), so that it can be further elaborated and finalized in view of the 17th Meeting of the MCSD.

Context and Background

2. The MSSD 2016-2025 was prepared and endorsed by the MCSD through a highly inclusive process. It was adopted by the Contracting Parties to the Convention for the Protection of the Marine Environment and the Coastal Region of the Mediterranean (Barcelona Convention) at their 19th Ordinary Meeting (COP19, Athens, Greece, February 2016), as a strategic guiding document for all stakeholders and partners to translate the 2030 Agenda for Sustainable Development (2030 Agenda) and its Sustainable Development Goals (SDGs) at the regional, sub-regional and national levels (Decision IG.22/2).

3. This plan provides a framework to promote and facilitate the implementation and monitoring of the MSSD 2016-2025. It is based on Chapter 3 of the Strategy, which highlights that the implementation is a collective process: while facilitated by the MAP system, it is the participation and active role of all stakeholders, *in primis* national governments, which will play a decisive role in its delivery.

4. The MSSD 2016-2025 also highlights the important role of the MAP system, which includes the MCSD and its Steering Committee, and the UNEP/MAP-Barcelona Convention Secretariat including all its Components, in providing leadership and guidance with respect to implementing the Strategy.

5. Recent activities related to the implementation of the Strategy were presented in the *Progress report by the Secretariat on the activities carried out for the period March-August 2016* (Document UNEP(DEPI)/MED BUR.83/3) submitted to the 83rd Meeting of the Bureau of the Contracting Parties to the Barcelona Convention and its Protocols (Tirana, Albania, 25-26 October 2016) and are also presented in the *Progress Report* submitted to the 18th Meeting of the MCSD Steering Committee (Document UNEP(DEPI)/MED BUR.428/3).

6. The Plan described in this document will be possible only with the adequate commitment, awareness-raising and advocacy by the parties listed above, including to mobilize the necessary political will (for example through the Barcelona Convention governance structure), the visibility and the resources that are pre-conditions for its success. Furthermore, it is necessary for all Members of the MCSD to ensure that its dissemination and application is as wide as possible, with the support of the Secretariat.

7. The MSSD 2016-2025 mentions the following as essential tools for the implementation of the Strategy:

- a. The Protocol on Integrated Coastal Zone Management for the Mediterranean (ICZM Protocol);
- b. The Roadmap for the implementation of the Ecosystem Approach in the Mediterranean (EcAp Roadmap);
- c. The Strategic Action Programme for the conservation of Biological diversity in the Mediterranean region (SAP BIO);
- d. The Regional Action Plan for Sustainable Consumption and Production in the Mediterranean (SCP AP);

- e. The Strategic Action Programme of regional and national activities to address land-based pollution;
- f. The Marine Litter Regional Plan;
- g. The Offshore Action Plan;
- h. The Regional Climate Change Adaptation Framework for the Mediterranean Marine and Coastal Areas (RCCAF);
- i. The action programmes of the Union for the Mediterranean (UfM);
- j. The Mediterranean Strategy on Education for Sustainable Development (MSESD).

8. In addition to those essential tools for implementation, the MSSD 2016-2025 indicates that the MAP system will provide support to the Contracting Parties for the implementation of the Strategy. This support may include technical guidance, the coordination of implementation actions and monitoring processes, as well as a platform for the exchange of relevant information, experience and synergies developed at regional or sub-regional level.

9. This document begins by outlining the objectives of the MSSD monitoring and implementation process, then provides a list of actions related to these objectives. It continues by outlining a list of priority areas for implementation, and concludes with a work plan.

10. The actions listed below are called for by the MSSD 2016-2025. It is expected that the MCSD Steering Committee will review this set of actions and provide comments, including suggestions on how to implement them.

Objectives

- 11. The objectives of the MSSD 2016-2025 implementation and monitoring process are:
 - a. to raise awareness amongst key stakeholders and implementers about the Strategy;
 - b. to identify the optimal mechanisms for the participation of national institutional frameworks responsible for sustainable development in the implementation of the Strategy's actions at the national level;
 - c. to collect baseline and updated data on monitoring indicators related to all the MSSD 2016-2025 actions, formulating a monitoring database, as well as a Mediterranean Sustainable Development Dashboard with a set of populated indicators;
 - d. to explore a variety of tools and processes that might be used to implement the Strategy;
 - e. to report on progress on the MSSD 2016-2025 implementation and monitoring to the MCSD and the Contracting Parties every two years, establishing synergies with other existing sustainable development mechanisms and monitoring systems at regional and global level; and,
 - f. to ensure successful implementation of the Strategy and of the 2030 Agenda and its SDGs at the regional, sub-regional and national levels.

Actions for the MSSD 2016-2025 Implementation and Monitoring (based on Chapter 3 of the Strategy):

- 12. Structures for implementation of the MSSD 2016-2025:
 - a. Report on and encourage, when possible by targeted trainings and capacity development activities, the setting up of national sustainable development commissions, councils, fora, and networks as appropriate (in line with Action 7.1.1 of the MSSD 2016-2025);
 - b. Strengthen resources for Sustainable Development at the UNEP/MAP-Barcelona Convention Secretariat (in line with Action 7.1.2);

- c. Ensure wider participation with stronger involvement of Main Groups of Stakeholders (MGS), which is central in the COP19 Decision IG.22/17 on the MCSD Reform (in line with Action 7.1.3);
- d. Carry out activities to raise awareness on the MSSD 2016-2025 with key stakeholders to improve visibility, including within the United Nations system (in line with Action 7.1.4); and,
- e. Promote exchange of good practices and networking by the MCSD and, in case funding available, create specific mechanism for exchange of best practices between the Contracting Parties and MGS (in line with Action 7.1.5).

13. The on-going test of the Simplified Peer Review Mechanism (SIMPEER), as decided in COP19 (Decision IG.22/17 – Annex II) is fully in line with points a) and e) above. The SIMPEER aims at engaging a dialogue between volunteer Mediterranean countries, on equal participation, for a mutual improvement and learning process on National Strategies for Sustainable Development (NSSDs). The SIMPEER seeks to establish the exchange of experiences, policies and good practices on implementing sustainable development at national level. The SIMPEER represents an important incentive to enable NSSDs review in line with the MSSD 2016-2025 and as a contribution to the global 2030 Agenda and its SDGs specifications.

- 14. Regional process for monitoring and implementation of the MSSD 2016-2025:
 - a. Allocate funding within MAP system for MSSD 2016-2025 monitoring and implementation (in line with Action 7.2.1);
 - b. Prepare an implementation plan of the Strategy (in line with Action 7.2.2);
 - c. Prepare guidelines for countries to adapt the Strategy to national contexts and undertake capacity-building measures (in line with Action 7.2.3);
 - d. Undertake a participatory midterm evaluation of the Strategy based on the first 5 years of data (in line with Action 7.2.4); and,
 - e. Review the MSSD 2016-2025 with a view to formulate a new MSSD 2026-2035 (in line with Action 7.2.5).

15. It should be noted that point a) above is dealt with the UNEP/MAP Programme of Work and Budget, point b) is dealt with the present document, and point c) with the SIMPEER process.

16. Strengthening capacity for financing the implementation and monitoring of the MSSD 2016-2025:

- a. Prepare a funding strategy, to be followed up by donor outreach, and a project portfolio associated with possible funding sources (in line with Action 7.3.1);
- b. Organize capacity-building workshops for Contracting Parties and stakeholders on fundraising (in line with Action 7.3.2);
- c. Set up a Mediterranean Investment Facility for sustainable development (in line with Action 7.3.3); and,
- d. Undertake actions to encourage private sector to engage with civil society and foster greater corporate social responsibility (in line with Action 7.3.4), which is similar to Action 21 under the SCP Action Plan, Appendix 1 (Roadmap for Implementation).

17. It should be noted that point a) above will be covered in the overall updated Resource Mobilization Strategy of the UNEP/MAP-Barcelona Convention (under preparation, for adoption at COP 20).

18. Monitoring the MSSD 2016-2025:

- a. Ensure the provision of regular biannual support from the Contracting Parties and stakeholders to the Secretariat in providing data for monitoring the Strategy (in line with Action 7.4.1);
- b. Use the meetings of the MCSD to monitor the implementation of the MSSD 2016-2025, facilitated through break out groups (in line with Action 7.4.2);

- c. Link the Strategy's monitoring systems with the wider UNEP/MAP-Barcelona Convention data and information systems (in line with Action 7.4.3); and,
- d. Set up a dashboard of sustainability indicators (in line with Action 7.4.4).

19. It should be noted that point d) – and partly point c) – above are dealt with the Mediterranean Sustainable Development Dashboard, developed by the Secretariat through its Plan Bleu Regional Activity Centre. Point b) will be initially implemented at the forthcoming 17^{th} Meeting of the MCSD.

20. Overall, the implementation of the Strategy will be also facilitated through the promotion of awareness and education for sustainable development. In this respect, the Action Plan of the Mediterranean Strategy on Education for Sustainable Development (a Strategy endorsed by the UfM Ministers of Environment and Climate Change in Athens, May 2014) adopted by the "Ministerial Conference on the Action Plan for Education for Sustainable Development in the Mediterranean" (Nicosia, Cyprus, 8-9 December 2016) is directly related to the MSSD 2016-2025.

Priority Areas for Implementation

21. The MSSD 2016-2025 contains two types of priority actions: those related to Targets and those related to the Flagship Initiatives, both of which should be accorded specific attention in the implementation process.

22. The list of the MSSD 2016-2025 Targets is presented in Table 1 below.

Work Plan for the MSSD 2016-2025 Implementation and Monitoring

24. The main elements of the work plan for the MSSD 2016-2025 implementation and monitoring are provided in Table 3 below. The implementation is on-going for several actions (see also Progress Report, Document UNEP(DEPI)/MED WG.428/3). A more detailed work plan with key dates for the MSSD 2016-2025 implementation and monitoring process, and with further information on responsible actors and partners for the MSSD 2016-2025 implementation, will be developed at the next stage, based on the actions presented in this document and following the suggestions by the MCSD Steering Committee. A more detailed work plan could also consider indicative values of the necessary resources for the implementation of the priority actions.
