**2. Preparations for the special session on the commemoration of the creation of the United Nations Environment Programme (UNEP@50).**

**a) Update on the consideration of a theme for the UNEP@50 commemoration.**

The Chair will report on the outcome of the consultations regarding the consideration of a theme for the special session, and as agreed at the 156<sup>th</sup> CPR meeting.

**b) Provisional agenda and draft structure for the special session.**

The Secretariat will present the revised provisional agenda and draft structure taking into consideration the feedback received during the 156<sup>th</sup> meeting of the CPR. This presentation will be followed by an exchange of views with Member States.

**c) General approach for the leadership dialogues and the multi-stakeholder dialogue.**

The Secretariat will present the general approach for the organization of the two High Level Leadership Dialogues of the special session (Looking back - 50 years of UNEP, and Looking forward - Achieving the 2030 Agenda for people and planet), and of the Multi Stakeholder Dialogue. After these presentations, Member States will be invited to provide their feedback and views on the organization of these dialogues.

**d) Update on the communications strategy for UNEP@50.**

The secretariat will provide an update on the communication strategy for the commemoration of the fiftieth anniversary of UNEP. This presentation will be followed by an exchange of views with Member States.

**e) General discussion on a possible Chair's summary.**

As agreed in the 156<sup>th</sup> CPR meeting, the Subcommittee will be invited to exchange views on a possible summary of the chair that would be presented at the closing segment of the special session.
