Introduction

- 1. In accordance with Article IV.2 of the Terms of Reference of the Bureau and in consultation with the President and members of the Bureau, the 93rd Meeting of the Bureau of the Contracting Parties to the Convention for the Protection of the Marine Environment and the Coastal Region of the Mediterranean (Barcelona Convention) and its Protocols will be held in Thessaloniki, Greece, on 30 November 1 December 2022.
- 2. The following annotations to the Provisional Agenda have been prepared by the Secretariat to assist the meeting in its deliberations.

12. The Coordinator will present the "*Report by the Secretariat on Specific Issues*" (UNEP/MED BUR.93/6). The Bureau will be invited to consider the following issues:

(a) Ratification, Reporting and Compliance

- 13. The Secretariat will present an update on the status of ratification of the Barcelona Convention and its Protocols. The Bureau is expected to discuss ways to further promote ratification of the Barcelona Convention and its Protocols.
- 14. The Secretariat will also provide an update on the status of implementation of Decision IG.23/1 on *Revised Reporting Format for the Implementation of the Barcelona Convention and its Protocols*.
- 15. The Secretariat will present the progress in relation to the Procedures and Mechanisms on Compliance under the Barcelona Convention and its Protocols, including the implementation of Decision IG.25/2 on *Compliance Committee*.
- 16. The Bureau is expected to discuss these issues and provide its guidance.

- 17. The Secretariat will inform on the progress in relation to key COP 22 mandates, with a focus on the processes and on the actions taken as well as on the next steps for their efficient delivery.
- 18. The Bureau members will be invited to discuss, and provide guidance on the way forward, considering also the text of the relevant COP 22 Decisions and of the Antalya Ministerial Declaration.

(c) Collaboration and Partners

- 19. The Secretariat will update the Bureau on the efforts to contribute to regional governance and cooperation, as well as to create new partnerships and strengthen and update existing ones, in order to enhance the impact of the MAP-Barcelona Convention system.
- 20. With reference to Decision IG.19/6 on MAP/Civil society cooperation and partnership, the Secretariat will present to the Bureau members the outcome of the evaluation of the applications received by civil society organizations for accreditation, as well as for renewal of accreditation, as MAP Partners, for the Bureau's review and possible endorsement.

(d) Outreach, Communication and Advocacy

21. The Secretariat will report on the information and communication activities conducted and on the plans for the current biennium in this area, in the context of the most important global and regional events. The Bureau will be invited to provide its views and considerations on this matter and to advise on how to further enhance the outreach, visibility and impact of the MAP – Barcelona Convention system including on the outcome of COP 22.

(e) Ways and Means to Streamline Reporting on Progress and on Implementation of COP Decisions

- 22. The Secretariat will present to the Bureau members some considerations on possible ways and means to streamline reporting on progress and on implementation of COP Decisions, including on the implementation of the Programme of Work and Budget.
- 23. The Bureau members will be invited to discuss, and provide guidance on the way forward.

(f) Proposal to Strengthen the Institutional Setup of UNEP/MAP on Climate Change

- 24. Following the relevant discussions at the 92nd Bureau meeting (Istanbul, Türkiye, 24-25 March 2022) the representative of Türkiye will present to the Bureau members a proposal to strengthen the institutional setup of UNEP/MAP on Climate Change, including through the possible establishment of a new Regional Activity Centre (Information Document UNEP/MED BUR.92/Inf.6).
- 25. The Bureau members will be invited to discuss the proposal, and provide guidance on the way forward.
