# International meeting entitled "Stockholm+50: a healthy planet for the prosperity of all – our responsibility, our opportunity"

### **Logistical arrangements**

The international meeting entitled "Stockholm+50: a healthy planet for the prosperity of all – our responsibility, our opportunity" will be held pursuant to General Assembly resolutions 75/280 and 75/326 on 2 and 3 June 2022 in Stockholm, Sweden.

# List of speakers

Requests for inscription from States participating in the international meeting and the European Union should be sent through the eSpeakers module accessible through the edeleGATE portal (under Conference>Stockholm+50) before 5 p.m. on 16 May 2022. The live rolling list of speakers will be circulated via e-deleGATE and announced in the Stockholm+50 edition of the Journal of the United Nations.

#### Pre-recorded video statements

At its 71st meeting on Tuesday, 10 May 2022, the General Assembly adopted decision 76/562, by which it decided "that States and the European Union speaking at the plenary meetings may each submit a pre-recorded statement of their Head of State or Government, which will be played during the general debate of the international meeting, following its introduction by the presiding officer.

As outlined in the letter from the Co-hosts of the international meeting (Sweden and Kenya) transmitted by the President of the General Assembly through his <u>letter dated 29 April 2022</u>, the Co-hosts intend to accommodate both in- person as well as pre- recorded video statements from all participating States and other stakeholders as mandated by GA resolution <u>75/326</u> and inscribed on the list of speakers for the general debate. It was further proposed that the pre-recorded video statements received from the speakers other than Heads of State or Government be published on the <u>Stockholm+50 website</u>, and that a decision to include their content into the summary of the discussions of the international meeting be taken at the first meeting of Stockholm+50, at the proposal of the Co-Presidents of the international meeting.

Participating States and the European Union are therefore invited to indicate whether they will be submitting a pre- recorded video statement through the eSpeakers function for Stockholm+50 on the e- deleGATE platform. In case the statement will be pre-recorded, please indicate this in the comment box on the platform. If a request for inscription has already been submitted, please update the text in the comment box to indicate that the statement will be pre-recorded.

Representatives of intergovernmental organizations international financial institutions and other international bodies are requested to express their interest in delivering a statement, time permitting, during the general debate to the Secretariat (galindo@un.org).

The guidelines for the submission of pre-recorded video messages will be provided by the Secretariat in due course to those participants who indicate their intention to submit a pre-recorded video in their inscription to the list of speakers.

The time limit for all statements (in- person as well as pre-recorded) will be three minutes for individual delegations and five minutes for statements made on behalf of a group. It should be noted that speakers' microphones or pre-recorded videos may be turned off in the event that speakers exceed their time limits.

All participants are requested to submit a written text of their interventions in Microsoft Word format to eStatements (estatements-splus50@un.org) well in advance of the meeting but no later than two hours before delivery, clearly indicating the date and time of the meeting, speaker and delegation.

Expressions of interest in the leadership dialogues

Pursuant to General Assembly resolution  $\frac{75/326}{}$ , Stockholm + 50 will include three leadership dialogues that will be held in parallel to the plenary meetings, as follows:

- Leadership Dialogue 1 on "Reflecting on the urgent need for actions to achieve a healthy planet and prosperity for all" (Thursday, 2 June 2022: 3 to 6 p.m.);
- Leadership Dialogue 2 on "Achieving a sustainable and inclusive recovery from the coronavirus disease (COVID-19) pandemic (Friday, 3 June 2022: 10 a.m. to 1 p.m.); and
- Leadership Dialogue 3 on "Accelerating the implementation of the environmental dimension of sustainable development in the context of the decade of action and delivery for sustainable development" (Friday 3 June 2022: 3 to 6 p.m.).

The leadership dialogues are open to all participants accredited to the international meeting, and will be webcast live on UNTV. Due to the seating arrangements in the conference room hosting the leadership dialogues, an established list of speakers will be prepared and shared ahead of the meeting, and only those reflected on that list will be provided with designated seating in the room. Due consideration will be given towards geographical and gender balance for the speakers, as well as ensuring the engagement of speakers from both participating States and stakeholders. Speakers are encouraged to focus their interventions on recommendations for actions to achieve a healthy planet for the prosperity of all.

It is envisaged that up to 25 States, 2 intergovernmental organizations, 2 specialized agencies and other United Nations system entities and 11 stakeholders would be accommodated to speak during the interactive debate of each dialogue. In order to provide for maximum participation, interventions should not exceed two minutes.

Participating States and the European Union are invited to express their interest in making an intervention during any of the three leadership dialogues in the order of their preference by clicking on the "register" button under the Conference> Stockholm+50 > Leadership dialogues tab on the e-deleGATE platform until Monday 16 May 2022 (at 5 p.m.). Instructions for the other categories of participants for submitting their expressions of

interest in the leadership dialogues are outlined in the Information note for participants (A/CONF.238/INF/1).
