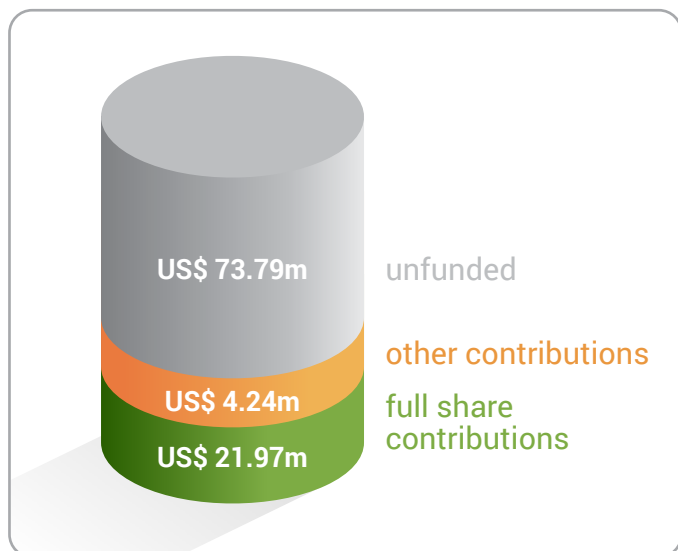

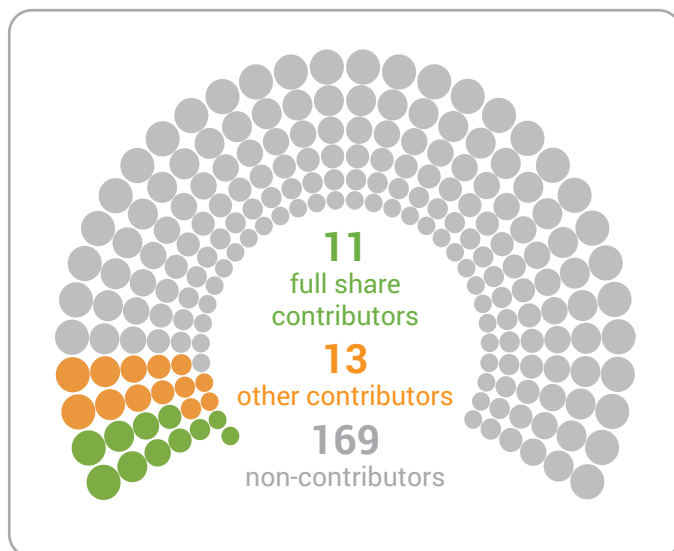
2023 CONTRIBUTIONS AS AT 30 APRIL 2023

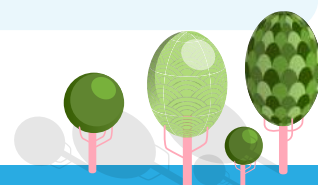

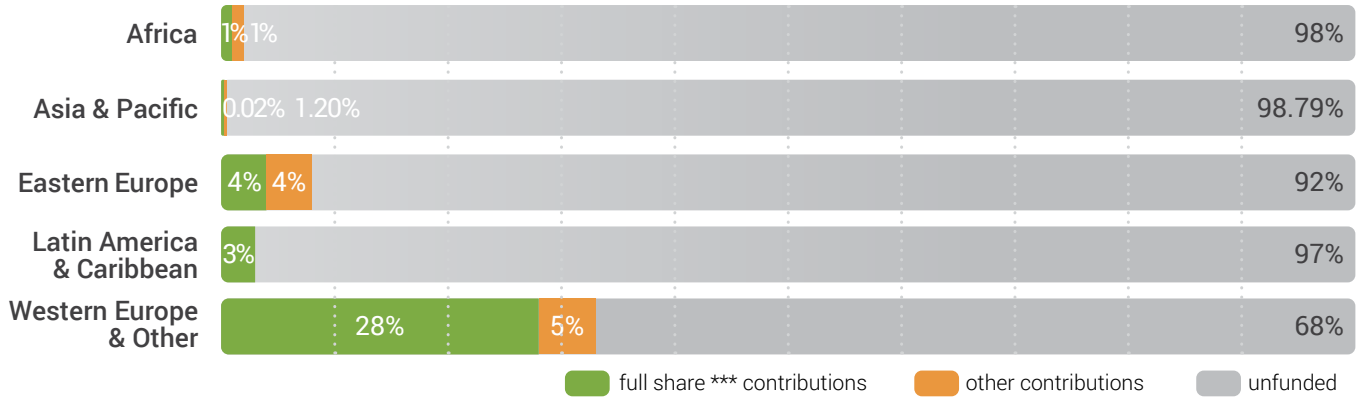

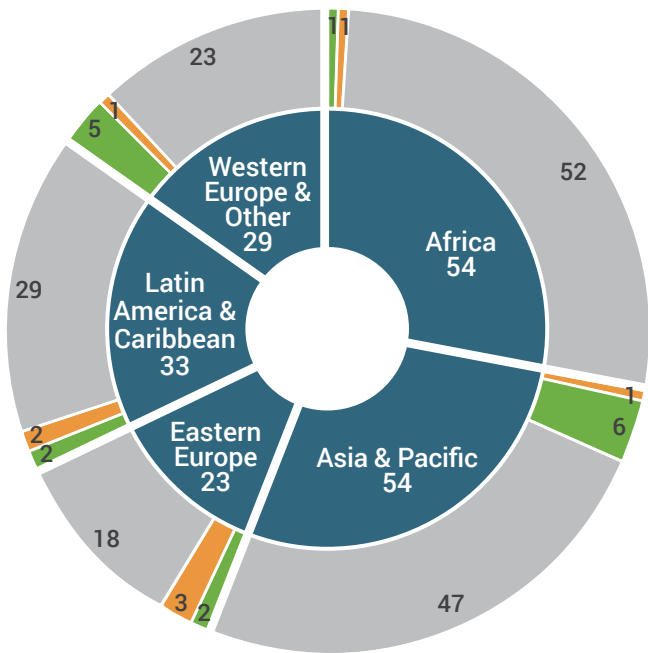
