**Twenty-third Global Meeting of Regional Seas Conventions and Action Plans** Barbados, 20- 23 November 2023

### Annotations to the agenda

### Introduction

The global meetings of the Regional Seas Conventions and Action Plans organized by UNEP is a coordination mechanism of the eighteen (18) regional seas conventions and action plans. This meeting provides a platform for adoption of global strategies for cooperation, channeling UNEP political and programmatic support to the Regional Seas Conventions and Action Plans, particularly in areas complementary to the UNEP Programme of Work and strengthening linkages between the Regional Seas Conventions and Action Plans and other relevant global conventions and agreements.

The 23rd global meeting of the Regional Seas Programme builds on the outcomes of the 22nd annual meeting held from 25- 27 May in Seychelles hosted by the Secretariat of the Nairobi Convention. The 22<sup>nd</sup> meeting kicked off the implementation of the Regional Seas Strategic Directions 2022-2025, deliberated on the resolutions endorsed at the resumed fifth session of the United Nations Environment Assembly (UNEA 5.2) such as the historic resolution to end plastic pollution and forge an international legally binding agreement by 2024. The meeting also discussed Regional Seas Programme's strategic involvement and contribution to the discussions on an internationally legally binding instrument under the Convention on the Law of the Sea on the conservation and sustainable use of marine biological diversity of areas beyond national jurisdiction (BBNJ), as well as the post 2020 Global Biodiversity Framework.

The 23rd global meeting will therefore develop a common action to implement the Regional Seas Strategic directions 2022-2025, including the Kunming- Montreal Global Biodiversity Framework, support to INC on Plastics, BBNJ and the World Ocean Assessments, strategic engagement of the Regional Seas at UN Ocean Conference in collaboration with the host government of France, Small Islands Developing States (SIDS) and Least Developed Countries (LDCs). The meeting will also deliberate on the UNEP Regional Seas Programme turning 50 years in 2024 among others.

### **Organizational matters**

Item 1. Welcome and opening remarks

The opening of the meeting will take place at 8:30 AM (Barbados time) on Monday 20 November 2023.

The meeting will be opened by Ms. Inger Andersen, Executive Director of UNEP via a video recording highlighting the main issues before the meeting.

At the opening, the meeting will hear welcoming address by Hon. Adrian R. Forde, Rph, the Minister of Environment, National Beautification and the Blue and Green Economy of Barbados. Thereafter Mr. Johan Robinson Head, Ecosystem Integration Branch, Ecosystems Division will deliver his statement.

This will be followed by introductions by the Executive Secretaries and representatives of Regional Seas Conventions and Action Plans.

### Item 2. Introductions and organization of the meeting

Ms. Nancy Soi, Programme Management Officer, Regional Seas Unit will introduce the objectives of the meeting and lead the meeting into adopting the agenda.

### Item 3. Update on progress from the last meeting

Thereafter, Ms. Soi will present the progress update from the 22<sup>nd</sup> Global Meeting on the Regional Seas Programme.

# Item 6. Regional Seas Conventions and Action Plans implementation of the Kunming-Montreal Global Biodiversity Framework – (Session facilitator: Ms. Tatjana Hema)

The facilitator of the session, Ms. Tatjana Hema, Coordinator UNEP MAP Barcelona Convention, will introduce the session and invite the speakers.

- a. The first presentation will set the scene and provide an overview of the Kunming-Montreal GBF goals and targets and key development by the CBD Secretariat to support its implementation. The presentation will be made by Mr. Joe Appiott from CBD Secretariat 12 minutes.

- c. A third presentation on a draft strategy for the Regional Seas Programme to support member states to implement the Kunning-Montreal GBF will be delivered by consultant Mr. Mikhail Paltsyn – 10 minutes.

Thereafter, Ms. Hema, will lead and moderate the plenary discussions on the Kunning-Montreal GBF implementation plan by the RSCAPs. The sessions will also be used to provide feedback towards supporting finalization of the RSP strategy to support countries achieve the K-M GBF by 2030 - 60 minutes.

### Item 7. Ocean Governance

The second day sessions will be focused on ocean governance and the topics for discussion include the plastic treaty, the BBNJ, the Third UN Ocean Conference, financing, and partnerships.

### Item 7.1 Plastic treaty (Session facilitator: Mahesh Pradhan, Coordinator, COBSEA)

The session will begin with thematic presentations with a focus on the Intergovernmental Negotiating Committee on Plastic Pollution, including in the marine environment.

a. The first presentation will be an update on the progress made by the Intergovernmental Negotiating Committee on Plastic Pollution by Ms. Jyoti Mathur-Filipp from the INC Secretariat – 12 minutes.

- b. The second presentation by Mr. David Ogden of the Basel, Rotterdam, and Stockholm Secretariats on sound management of chemicals and waste with a focus on plastics – 10 minutes
- c. The last presentation will be an overview of regional seas work on plastics and potential roles by consultant, Ms. Fadilah Ali **10 minutes.**

The session will conclude with a plenary discussion on plastic pollution, moderated by Mr. Mahesh Pradhan of the COBSEA Secretariat. The session will provide feedback and ideas to reshape the draft document on potential role of regional seas Programme supporting implementation of the plastics treaty once adopted. - **110 minutes**

### Item 7.2 BBNJ (Session facilitator: Dixon Waruinge, Coordinator, Nairobi Convention)

The session will have two in one thematic discussion. The first part will focus on BBNJ Agreement, understanding the treaty, obligations to member states, and the next steps to support adoption and ratification. The second part of the session will discuss the World Ocean Assessments and linkages with the regional assessments conducted by the regional sea's conventions and action plans and how the two assessments could feed into each other, i.e., looking at complementarities in topics covered, regional and global experts, among others.

a. The first presentation will be on the new agreement under the United Nations Convention on the Law of the Sea on the conservation and sustainable use of marine biological diversity of areas beyond national jurisdiction (BBNJ) by Ms. Charlotte Salpin and Mr. Fernando Cabrera Diaz from UNDOALOS – **12 minutes.** 

Thereafter, Mr. Waruinge will open the floor for moderated discussions aimed at identifying potential role and areas for collaboration between UNDOALOS, UNEP and Regional Seas Conventions and Action Plans.

b. The second presentation will be on the World Ocean Assessment, presented by Ms. Charlotte Salpin and Mr. Fernando Cabrera Diaz from UNDOALOS – **12 minutes.** 

This will also be followed by plenary discussion on the World Ocean Assessment, moderated by Mr. Dixon Waruinge from Nairobi Convention, will conclude the session. The session will also seek to provide a possible coherence and harmonized approach between the world ocean assessment and the regional assessments by the regional seas' conventions and action plans.

The facilitator of the session, Mr. Pattinson, will introduce the session and the speaker, Ambassador Olivier Poivre d'Arvor, French Ambassador for the Poles and Oceans, who will be joining online. Ambassador Olivier Poivre d'Arvor will provide an update on-going the preparations from Lisbon to Nice towards the 3<sup>rd</sup> UN Ocean Conference and propose strategic role of the regional seas conventions and action plans in supporting the preparation and at the conference in Nice.

a. The presentation on the Third UN Ocean Conference, roadmap from Lisbon to Nice, and the possible role of the Regional Seas Conventions and Action Plans by the French Ambassador for the Poles and Oceans, Mr. Olivier Poivre d'Arvor – **15 minutes** 

This will be followed by plenary discussion on UNOC 3 moderated by Mr. Dominic Pattinson of OSPAR. – **75 minutes**

The session will provide an update on progress in supporting member states to implement the SAMOA pathway including outcomes of the regional consultations on the priorities for the SIDS towards the 4<sup>th</sup> international conference on small islands developing states to be held in May 2024 in Antigua and Barbuda.

- c. Experiences from Caribbean SIDS by Mr. Vincent Sweeney and Ms. Susana Perera Valderrama of Cartagena Convention – 10 minutes
