Tenth heeting of the Inter-Agency Advisory Committee for MED POL

(Geneva, 4-8 May 1981)

MINUTES

INTRODUCTION

 The meeting was convened by the UNEP Co-ordinating Unit for the Mediterranean Action Plan in co-operation with UNEP's Regional Seas Programme Activity Centre. The following international organizations were invited to attend the meeting: FAO (GFCM), IOC of UNESCO, WHO, WNO and IAEA (members of the IAAC) and UNESCO.

ATTENDANCE

2. The meeting was attended by twelve representatives of the international organizations and UNEP. For the complete list of participants, see annex I to this report.

Agenda item 1. Opening of the Meeting

3. The meeting was opened by S. Keckes, Director of UNEP's Regional Seas Programme Activity Centre, who welcomed the participants and outlined the tasks to be undertaken by the Tenth Session of IAAC. He also introduced the various documents available to the meeting (annex II) and the provisional agenda which was unanimously adopted (annex III).

Agenda item 2. Review of the relevant decisions of the Second Neeting of the Contracting Parties to the Barcelona Convention

4. A. Manos, Co-ordinator of the Co-ordinating Unit of the Mediterranean Action Plan, briefly reviewed the outcome of the Second Meeting of the Contracting Parties to the Barcelona Convention (Cannes, 2-7 Narch 1981).

- 5. He said that the work of PHASE I of MED POL was considered to have been completed in December 1980, but some important documents relevant to this phase were still under preparation. The proposed Long-Term Pollution Monitoring and Research Programme had been adopted by the Contracting Parties as the follow-up to MED POL PHASE I to provide the technical/scientific background required for the implementation of the Barcelona Convention and its related protocols.
- 6. He also referred to other components of the Mediterranean Action Plan and reviewed the status of the recruitment of the additional staff of the Co-ordinating Unit of the Mediterranean Action Plan.
- 7. He also reminded the representatives of the international organizations that the budgetary allocation agreed upon by the Contracting Parties relevant to MED POL was US \$ 800,000 for 1981 and US \$ 1,100,000 for 1982 and that, as at the date of the meeting, very few countries had complied with their financial obligations, subjecting the activities to future availability of funds.

Agenda item 3. Review of the work on completion of MED POL - PHASE I

- 8. F.S. Civili introduced document UNEP/IAAC-X/3 and referred to the activities to be completed in the framework of MED POL PHASE I. He reported on the status of the preparation of the various documents relevant to MED POL PHASE I.
- 9. Following a discussion, a list of the activities to be completed and the documents to be prepared, specifying the input required from the co-operating agencies involved and the relevant timetable, was agreed and is presented as annex IV to this report.
- Agenda item 4. Review of workplan, timetable, budget and institutional implications for the implementation of MED PUL PHASE II
- 10. S. Keckes introduced document UNEP/IAAC-X/4 and asked the participants to analyse it and revise it in the light of the Long-Term Pollution Monitoring and Research Programme, MED POL PHASE II, (UNEP/IG.23/11 annex V) adopted by the Contracting Parties to the Barcelona Convention in Cannes, 2-7 March 1981.

- 11. He reminded the Committee that the activities relevant to PHASE II had to be planned for the period starting August 1981 and ending December 1982, and that the funds available for 1981 (US \$ 800,000) would be distributed between the activities required to complete MED POL - PHASE I (January - July 1981), PHASE II activities (August -December 1981) and the project support personnel for the entire period from 1 January 1981 to 31 December 1982.
- 12. He explained the proposed mechanisms for the implementation of MED POL PHASE II. In this connection, a discussion was held on the proposed relationship between UNEP and the collaborating agencies.
- 13. UNEP would describe in detail the proposed relationship between UNEP and the collaborating agencies in the project document which had to be prepared. This draft project document would be sent to the pertinent authorities of agencies represented at the meeting for approval with a letter inviting them to take part in the MED POL PHASE II.
- 14. The Committee produced a revised version of the proposed workplan and timetable for the implementation of MED POL PHASE II attached as annex V to this report.

Agenda item 5. Revision of project documents covering agency participation in MED POL - PHASE I

- 15. A revision of the individual project documents relevant to each agency was proposed in the light of the workplan already discussed (see annex IV). In this connection the agency representatives expressed concern about the absorption of the unexpended 1980 funds into the 1981 budget, with obvious detrimental effects on all MED POL activities.
- 16. The proposed revised budgets for the period January July 1981 were ias follows:

Agenda item 6. Preparation of new project documents covering agency participation in MED PUL - PHASE II

- 17. The Committee decided upon and prepared a single draft project document (annex VI) covering the participation of the collaborating agencies for the period August 1981 December 1982 according to the agreed workplan (annex V).
- 18. In addition, a summary budgetary proposal was made taking into account the overall budget assigned to the project for 1981 and 1982, the amount of money allocated for MED POL PHASE I activities and the provision of funds for project support personnel.
- 19. Annex VII to this report contains a tentative distribution of the available funds for 1981 and 1982 activities. This distribution was made taking into account the 75% 25% ratio between monitoring and research activities recommended by the Contracting Parties (UNEP/IG.23/11, paragraph 50), which would likewise apply to project support expenditures.
- 20. As a result of the above proposals, \$800,000 for MED POL activities in 1981 would be allocated as follows:

- to complete PHASE I (January-July 1981) US \$ 260,850

- to start PHASE II (August-December 1981) US \$ 321,150

- to project support personnel in 1982 US \$ 218,000

US \$ 800,000

21. It was agreed that each agency, in considering their participation in MED POL - PHASE II, would prepare a detailed budget, and provide supplementary information on agency inputs and participation costs, for the finalization of the project document.

Agenda item 7. Closure of the Meeting

- 22. The English version of these minutes with its annexes were unanimously adopted by the Committee.
- 23. The meeting was closed by S. Keckes and A. Manos on & May at 13.00 hours.

SECTION 2

PLACE OF PROJECT IN THE ENVIRONMENT PROGRAMME

2.1 Objectives, strategies and goals of the environment programme

The project is a contribution to the fulfilment of the objectives, strategies and goals of the Regional Seas Programme as amended by the Sixth Session of the UNEP's Governing Council (UNEP/GC.6/7). It contributes to the programme goal No. 14.

2.2 Anticipated contribution of the project to the Environment Programme

The project will contribute to:

- (i) geographically balanced implementation of the Regional Seas Programme;
- (ii) development of the Mediterranean Action Plan based on priorities as defined by the States of the region;
- (iii) efforts of States to develop and protect their marine and coastal resources through environmentally-sound practices and appropriate administrative measures:
- (iv) fulfillment of UNEP'S role as the Secretariat of the Barcelona Convention.

2.3 Purpose of the project

The project should provide the basis for the support of the specialized bodies of the United Nations system to the implementation of the second phase of the Co-ordinated Mediterranean Pollution Monitoring and Research Programme (MED POL - PHASE II).

SECTION 3 PROJECT IDENTIFICATION

3.1 Background data

As decided by the meeting of the Contracting Parties to the Barcelona Convention (Cannes, 2-7 March 1981) the implementation of the Mediterranean Action Plan (MAP) will continue to be under the overall co-ordination of UNEP, acting as the Secretariat of the Barcelona Convention. This co-ordination will be carried out through the Co-ordinating Unit of the MAP (MED COORUN) as part of UNEP's Regional Seas Programme. MED COORUN is expected to be transferred from its present location in Geneva to Athens in late autumn 1981.

In order to ensure the comparability of information on marine pollution obtained in various regions of the world and its input into UNEP sponsored global programmes, it remains the responsibility of UNEP's Regional Seas Programme Activity Centre to ensure this comparability and consequently to oversee the substance of the scientific work carried out under the assessment component of each, including the Mediterranean, regional seas programme.

The involvement of national institutions designated by the competent national authorities and the co-operation with the relevant UN and non-UN bodies is the basis on which UNEP developed in the past, and plans to develop in the future, the MAP, and in particular MED POL - PHASE II.

The financial resources available for the implementation of the MAP are from:

- (i) Governments through their participation in the Mediterranean Trust Fund or through their contributions in kind,
- (ii) UNEP through the Environment Fund,
- (iii) UN and non-UN bodies through their contribution in cash and/or kind to activities of common interest.

UNEP, as the organization entrusted with the overall co-ordination of the MAP and with the management of the Mediterranean Trust Fund, has been requested by the Contracting Parties "to enter into commitments for programme activities by giving priority to projects already under way in order to complete them, trying to economise on co-ordination costs and new activities".

With respect to the above request and in order to achieve the main goals of MAP through the most effective and cost-efficient co-ordinating mechanisms, and the simplest lines of communications between all parties involved, the following general procedures are envisaged:

(i) Co-ordination between MED COORUN and the Co-operating Agencies.

The overall co-ordination of activities envisaged according to this project document will be carried out by MED COORUN. Meetings of the Inter-Agency Advisory Committee (IAAC), composed of representatives of the Co-operating Agencies, will continue to be convened periodically by MED COORUN, to discuss general policies and strategies of project implementation. The day-to-day co-ordination of activities related to monitoring will be carried out by MED COORUN through a group of UNEP, WHO and FAO experts located at MED COORUN and with assistance of the other Co-operating Agencies providing support to the implementation of the monitoring programme. The day-to-day co-ordination of the research and the activities supporting the monitoring programme will be carried out by the relevant Co-operating Agencies.

(ii) Monitoring

The monitoring of the sources, amounts and levels of pollutants will be carried out through institutions designated by their national MED POL focal points on the basis of the comprehensive agreements (one per country) between UNEP, (as the Secretariat of the Barcelona Convention) and the national institutions designated by their respective national MED POL focal points. The contracts will specify the areas and pollutants to be monitored, the frequency of monitoring, the data reporting procedures, the assistance to be provided through the agreement and other details relevant to the agreed monitoring programme. The proposals for these agreements will be prepared jointly by MED COORUN and the Co-operating Agencies supporting the monitoring programme.

(iii) Research and activities supporting monitoring

The research and activities supporting the monitoring programme will be carried out by selected national institutions on the basis of agreements between the relevant Co-operating Agencies and the national institutions. Agreements will be concluded on the basis of competitive bids received from national institutions through their respective national MED POL focal points. Formats (style) of the research proposals and criteria for the evaluation of received research proposals will be elaborated jointly by the Co-operating Agencies and the MED COORUN.

The general principles reflected in the preceding paragraphs and the specific decisions of the Second Meeting of the Contracting Parties to the Barcelona Convention, Cannes, 2-7 March 1981, as contained in document UNE/IG.23/11, and in particular in Annex V to this document, which serves as the basis for the activities envisaged in this project document, are reflected in the following sections of the project document.

3.2. Description of project

3.2.1 Inputs

The project will be a joint undertaking of UNEP and the Co-operating Agencies in which each of them will contribute according to its field of competence.

MED COORUN will act as the overall co-ordinator of the project and will be specifically responsible for contacts with MED POL focal points on all matters related to the monitoring programme.

The Co-operating Agencies will:

- (i) participate in the development of the monitoring programme, in its day-to-day co-ordination, in the evaluation of the results and in supporting it through development of background material (surveys, studies, etc.) as necessary;
- (ii) develop and, on a day-to-day basis co-ordinate the implementation of agreed research and activities supporting the monitoring programme.

3.2.2 Activities

The planned activities of this project are specified in the attached annex.

3.2.3 Outputs

The project is expected to result in :

- (i) a viable programme of monitoring of the sources, amounts and levels of the pollution in the Mediterranean, as envisaged in the Convention for the Protection of the Mediterranean Sea against Pollution, and its related protocols;
- (ii) development of supporting activities, including a research programme, needed for the successful implementation of the monitoring programme.

3.2.4 Prerequisites and assumptions

It is assumed that the project will continue to receive active support from selected Co-operating Agencies and from the Governments of the region.

The financial resources available for the project are expected to be primarily those provided by the Governments of the region through the Mediterranean Trust Fund.

3.5 Cash Advance requirements

UNEP will issue sub-allotments on a yearly basis. The sub-allotment will be amended from time to time based on project budget revisions. The UN Secretariat/Subsidiary bodies will submit status of allotment reports to UNEP on a monthly basis in accordance with the UN Financial Procedures.

3.6 Counterpart contributions

Counterpart contributions of Co-operating Agencies will be provided in kind as services of their regular staff (see annex to this project document)

SECTION 4 REPORTS

4.1 Management Reports

(a) Half-yearly progress reports

The Co-operating Agencies shall submit half-yearly progress reports to UNEP as at 31 March and 30 September, within thirty days of the end of the period.

(b) Terminal reports

A terminal report will be submitted to UNEP by all Co-operating Agencies within sixty days of the completion of the project. The report should concentrate on the management of the project and should indicate the principal factors which determined the success or failure of the project in meeting the objectives set down in the project document.

4.2 Substantive reports

All Co-operating Agencies shall submit to UNEP three copies of all substantive documents (reports, surveys, etc) in draft, for clearance prior to their publication in final form. UNEP's views on the report and any suggestions for amendments will be conveyed expeditiously to the relevant co-operating agency with an indication of any disclaimer which UNEP might wish to see attached to the publication.

4.3 Financial reporting

The Co-operating Agencies shall submit to UNEP quarterly project expenditure accounts and final accounts showing amounts budgeted for the year, amounts expended since the beginning of the year and showing separately the unliquidated obliqations as follows:

- (a) As at 31 March, 30 June, 30 September and 31 December each year, providing details of unliquidated obligations separately;
- (b) The expenditure account as at 31 December to be received by UNEP by mid-February each year;
- (c) A final statement of account reflecting actual final expenditures under the project, when all obligations have been liquidated.

4.4 Terms and conditions

The Co-operating Agencies are authorized to enter into commitments or incur expenditures up to a maximum of 20% over and above the amount foreseen in the project budget under any sub-budget line, provided the total cost of the UNEP contribution to the project is not exceeded by more than 5%. This may be done without prior authorization but once the need for these additional funds becomes apparent, a revised budget request should be submitted to UNEP immediately. Cost overruns or more than 5% are the responsibility of the Co-operating Agencies unless a revised budget has been agreed with UNEP.

Any cost overrun (expenditure in excess of the budgeted amount) on a specific sub-budget line over and above the 20% flexibility mentioned above should be met by the organization which originally assumed responsibility for authorizing the expenditure, unless a revision has been agreed to by UNEP prior to the authorization to cover it. Saving in any budget line may not be applied to overruns of over 20% in other sub-budget lines, even if the total cost to UNEP remains unchanged, unless this is specifically authorized by UNEP upon presentation of the request.

SECTION 5 FOLLOW-UP ACTION

It is anticipated that the project will be extended beyond December 1982 in order to provide a long-term support to MED POL - PHASE II, which is at present planned, by the Contracting Parties to the Barcelona Convention, to be carried out in the period 1981-1990).
