**Consultation on the theme for the seventh session  
of the United Nations Environment Assembly**

### **Guidance on the theme for the seventh session of the United Nations Environment Assembly**

This note, entitled “Guidance on the theme for the seventh session of the United Nations Environment Assembly”, was considered by the Bureau of the United Nations Environment Assembly at its Bureau meeting held on 16 May 2024. At that meeting, the Bureau agreed to apply the guiding principles, criteria, timeline and consultation process outlined in this document as the way forward towards defining a theme for the seventh session of the Environment Assembly. The Bureau also requested the secretariat to prepare possible themes for the seventh session ahead of the joint meeting of the Bureau of UNEA-7 and the CPR Bureau scheduled for 26 June 2024.

## **I. Introduction**

The United Nations Environment Assembly, as the highest-level global decision-making body on environmental issues, provides an unparalleled platform for countries to come together to tackle pressing environmental issues. It is a forum with unique authority to reach global agreement on the most pressing and emerging environmental issues. Armed with the right focus and political resolve, the Assembly has put science on the global multilateral table and shaped historic results for people and planet. It has provided a biennial boost to action on a range of issues, particularly those that are not the focus of specific conventions.

The Executive Director of the United Nations Environment Programme, in her report to the sixth session of the Environment Assembly, stated that “the Environment Assembly must be a standard-bearer as an effective, inclusive and multilateral forum where solutions are sought and agreement is reached: an Assembly that watches over the world, scales up action and responds to its most critical challenges, an Assembly that highlights emerging environmental issues while scanning the horizon for future problems, an Assembly that consolidates agendas, decisions and stakeholders to fill the gaps in international environmental governance, a bolstered Assembly that can play its part in revamping multilateralism while providing greater capabilities to the entire United Nations system and Member States to achieve the Sustainable Development Goals”.

The seventh session of the Environment Assembly will take place after the fourth International Conference on Small Island Developing States, to held in Antigua and Barbuda from 27 to 30 May 2024, on the theme “Charting the course toward resilient prosperity”; the Summit of the Future, to be held in September 2024, aiming to build upon the Sustainable Development Goals Summit and deliver an action-oriented Pact for the Future to accelerate progress towards the Sustainable Development Goals, the 16<sup>th</sup> Conference of the Parties to the United Nations Convention on Biological Diversity scheduled for October 21 to November 1 2024, in Cali, Colombia, as well as the 16<sup>th</sup> session of the Conference of the Parties to the United Nations Convention to Combat Desertification to be held in in Riyadh, Saudi Arabia, on 2-13 December 2024.

In addition, the "Second World Summit for Social Development" will convene in 2025 to address gaps, recommit to the principles outlined in the 1995 Copenhagen Declaration on Social Development and Programme of Action, and give momentum to the implementation of the 2030 Agenda for Sustainable Development. Also, a high-level United Nations Conference to Support the Implementation of Sustainable Development Goal 14: Conserve and sustainably use the oceans, seas and marine resources for sustainable development (the 2025 UN Ocean Conference) will be co-hosted by France and Costa Rica and held in Nice, France, from 9 – 13 June 2025, and the 30<sup>th</sup> session of the parties to the United Nations Framework Convention on Climate Change is scheduled for mid-November 2025.

Furthermore, pursuant to UNEA resolutions the intergovernmental negotiating committee to develop an international legally binding instrument on plastic pollution, including in the marine environment, as well as the ad hoc open-ended working group on a science-policy panel to contribute further to the sound management of chemicals and waste and prevent pollution, are expected to have completed their work by the end of 2024.

Importantly, the Environment Assembly will be approving UNEP's draft programme of work and budget for the period 2026-2027 and the draft medium-term strategy for the period 2026-2029 at its upcoming seventh session.

As the world's only universal-membership forum for the environment, the Environment Assembly can provide a platform for courageous decisions and new ideas to come to the fore. This can be achieved starting with a focused and strategic theme which gives Member States and stakeholders clear directions towards an ambitious and bold seventh session of the Environment Assembly.

## **II. Mandates**

### ***Decision 6/7 on the provisional agenda, date and venue of the seventh session of the Environment Assembly:***

The United Nations Environment Assembly (UNEA), in its decision 6/7 of its sixth session entitled "Provisional agenda, dates and venue of the seventh session of the United Nations Environment Assembly":

- a. Decided that the **seventh session** will be held in **Nairobi from 8 to 12 December 2025**.
- b. **Requested the Bureau of UNEA**, in consultation with the Committee of Permanent Representatives (CPR), **to define a theme for the seventh session** of the Environment Assembly no later than **twelve months in advance of the seventh session**.

This entails that the Bureau of UNEA should define the theme in early December 2024, at the latest.

### ***Final outcome of the Consensual Process for Review by the Committee of Permanent Representatives***

In the final outcome of the Consensual Process for Review by the CPR, as endorsed by UNEA in its decision 5/4, the specific guidance relating to the theme of UNEA reads as follows:

- a. Under the guidance of the UNEA Bureau and the Secretariat, **ensure that the UNEA theme provides a framework for political debate at the high-level segment as well as for official UNEA events**, including UNEA side events, the Major Groups and Stakeholder Forum, and the Sustainable Innovation Expo and the Science Policy Business Forum, and that **it informs Member States in their preparation of draft UNEA resolutions**, while fully respecting Member States' right to table draft resolutions on any subject in accordance with the UNEA Rules of Procedures (paragraph 1).
- b. Under the guidance of the UNEA Bureau and with the support from the Secretariat, and taking into account inputs from Major Groups and Stakeholders, **strengthen the science-policy interface at UNEA** by:
  - o **Facilitating science-based decision-making**, where relevant, through dedicated briefings and consultations on the theme of UNEA and/or proposed resolutions, as appropriate (paragraph 8 (a)).

- c. In accordance with the UNEA Rules of Procedures and established practices, including as outlined in the UNEP Stakeholder Engagement Handbook, **strengthen the participation of and meaningful involvement of representatives of Major Groups and Stakeholders at UNEA and its preparatory process**, including in the context of selecting the UNEA theme ... (paragraph 9).
- d. The Bureau shall, in consultation with members of regional groups ... prepare for the sessions of UNEA, including **by providing guidance on the selection of an overarching theme** ... (paragraph 16, A.111 (c)).

### **III. Proposed guiding principles for defining the theme for UNEA-7**

The Bureau of UNEA has a unique responsibility to define the main theme that will advance the work of the Environment Assembly.

The choice of theme is very important, as it contributes to the framing, authority, relevance and effectiveness of the Assembly and its outcomes. Therefore, in making their decision, the Bureau may wish to consider the following principles which have guided past sessions:

- The theme should contribute to the implementation of commitments included in the 2030 Agenda, the Multilateral Environmental Agreements (MEAs), and relevant resolutions and declarations adopted by previous sessions of the Assembly.
- The process to define the theme should be based on broad, inclusive and transparent consultations, including the Committee of Permanent Representatives and major groups and stakeholders.
- The theme should provide the vision and sound political backing for an ambitious ministerial outcome document and a limited number of draft resolutions.
- The theme should be agreed in a timely manner and at the latest by early December 2024.

### **IV. Basic criteria for defining a theme.**

Lessons learned from past UN Environment Assemblies point to the importance of timely identification of politically appealing and strategic themes. To facilitate the process, the following basic set of criteria have proven useful, namely, that the theme should:

- Provide clear vision and focus for UNEA-7
- Contribute to addressing the root causes of present environmental challenges as well as highlighting any emerging environmental issues that warrant international debate and policy guidance.
- Promote the development of science-based, actionable and solution-oriented outcomes that can deliver against multiple Sustainable Development Goals.
- Ensure alignment with the mandate of the Environment Assembly and relevance for the United Nations system as a whole.
- Be crisp, concise, easily communicable and understood by a specialist as well as general public.

## **V. Proposed timeline for consultations.**

The Bureau may wish to consider the proposed timeline for consultations on the theme:

### May 2024

- Initial discussion in the Bureau of UNEA.

### June/July 2024

- Joint meeting of UNEA and CPR Bureaux to consider proposals for a theme, based on the proposals provided by the secretariat.
- Consultations with regional and political groups under the leadership of members of the UNEA and CPR Bureaux members.
- Consultations under the Committee of Permanent Representatives, including in the context of the 11th annual subcommittee meeting.

### September/October 2024

- Additional consultations convened by the President.

### November 2024

- Additional consultations, as needed.
- Additional consultations with regional and political groups through the UNEA and CPR Bureaux members, as needed.

### December 2024

- UNEA Bureau meeting - Final decision by the UNEA Bureau on the theme.
