REPORT OF THE EXECUTIVE DIRECTOR ON THE IMPLEMENTATION OF THE MEDITERRANEAN ACTION PLAN IN 1982 AND RECOMMENDATIONS FOR ACTIVITIES TO BE UNDERTAKEN IN THE 1984 - 1985 BIENNIAL WITH RELATED BUDGET PROPOSALS

Agenda item 8 (a) - The Blue Plan

1. The recommendations of the Executive Director for the further work of the Blue Plan were prepared without the benefit of the views expressed by the meeting of National Focal Points which met at Sophia Antipolis from 31 January to 2 February 1983. The report of that meeting has since been circulated in document UNEP/IG.43/INF.4. The meeting recommended that a work programme for 1983 be prepared for the third ordinary meeting of Contracting Parties (recommendation 4). This is hereby submitted for approval.

Proposed Work-Plan 1983

March - April 1983 Preparation of summary reports on the twelve seminars.

May 1983 Seminar on Methodology of Blue Plan and Mediterranean basin perspective in global prospective studies (Sophia Antipolis, jointly with Medeas, IIASA and other organisations).

May - September 1983 Seven small meetings, with country officials or specialists.

30 June 1983 Deadline for suggestions on Phase Two and corrections on final report from Focal Points.

July 1983 Meeting with 24 experts of the twelve studies.

1 September 1983 Final report of Phase One and of detailed proposals for Phase Two.

Mid-September 1983 Twelve seminars reports ready.

End September 1983 Despatch of all documentation to Focal Points.

End October 1983 Meeting of National Focal Points

November - December 1983 Start of Phase Two.

2. The Meeting of National Focal Points further recommended (recommendation 5) that another meeting of Focal Points be convened before the end of 1983 with a mandate to:

- a) examine the results of Phase One
- b) examine and adopt the programme of Phase Two

and that the Contracting Parties provide within the 1984-1985 budget an amount to enable activities of Phase Two of the Blue Plan to be carried out in a normal way. (recommendation 6):
