## Introduction

The present meeting of the National Focal Points for the Blue Plan is convened by the Secretariat to review and evaluate the results of the second phase of the Blue Plan, 1986-1987, as a follow-up to the recommendations of the Fourth Ordinary Meeting of the Contracting Parties held in Genoa, 9-13 September 1985, and to agree on a set of recommendations for 1988-1989 Blue Plan activities and their related budget to be submitted for adoption at the forthcoming Fifth Ordinary Meeting of the Contracting Parties (Athens, 7-11 September 1987).

The following annotations to the proposed agenda for the meeting were prepared by the secretariat to assist the meeting in its deliberations.

### Agenda item 1. Opening of the Meeting

The Meeting will be opened at 09.30 hours on Monday, 20 July 1987 in the Conference room of BP/RAC premises, Sophia Antipolis, by the representative of the Executive Director of UNEP.

### Agenda item 2. Rules of Procedure

The rules of procedure adopted for meetings and conferences of the Contracting Parties to the Convention for the protection of the Mediterranean Sea against pollution and its related protocols will apply, mutatis mutandis, for the Meeting (UNEP/IG/43/6, Annex XI).

### Agenda item 3. Election of Officers

The meeting will be invited to elect a chairman, two vice-chairmen and a rapporteur.

### Agenda item 4. Adoption of the Agenda

The meeting will be invited to adopt its agenda. The provisional agenda has been circulated as document UNEP/WG.171/1

The meeting will review and adopt the proposed timetable appearing in the Annex to the present document.

The working languages of the meeting will be English and French, with simultaneous translation.
