In accordance with the decision taken by the 12th MCSD meeting held in Istanbul, Turkey, the 13th meeting of the MCSD will be held on 28-30 September 2009 in Cairo, Egypt at the kind invitation of the Minister of State for Environmental Affairs, Mr. Maged Georges.

In agreement with the MCSD steering Committee, the main theme of the 13th MCSD meeting will be "Climate Change Adaptation Experiences and Strategies in the Mediterranean'. The main objectives of the meeting is to discuss and agree on issues related to MCSD main statutory agenda as per its rules of procedure as well as to enable the MCSD to provide advice

to the Contracting Parties on priority regional and national measures to adapt to climate change.

Day I, 28 September 2009

08.00 – 09.00 Registration

09.30 – 10.30 Agenda item1: Opening

The meeting will be opened by the current President of the MCSD Steering Committee elected at its 12th session held in Istanbul, Turkey in 2007;

Welcome address will be delivered by H. E. the Minister of State for Environmental Affairs, Mr. Maged George, the Officer in Charge and Deputy Coordinator of MAP Ms. Maria Luisa Silva;

Professor Mohammed El Raye will deliver a key note address on Climate Change.

Agenda item 2: <u>Election of the Steering Committee</u>

In conformity with the Rules of Procedure of the MCSD, at the commencement of the first sitting of each meeting, the Commission shall elect the Steering Committee which shall be composed of a President, five Vice-Presidents and a Rapporteur. The Steering Committee shall include four members representing the Contracting Parties, including ex-officio the President of the Bureau of the Contracting Parties, and one representative from local authorities, socio-economic actors and NGOs.

11.00-11.30 Agenda item 3: Adoption of the Agenda and organization of work

The Rules of Procedure of the MCSD provide that at the beginning of each session, after the selection of the Steering Committee, the meeting adopts the agenda on the basis of the provisional agenda.

11.30-13.00 Agenda item 4: <u>Report by the Secretariat on the progress</u> achieved, sustainable development activities and emerging issues

The MAP Officer in Charge/Deputy Coordinator will introduce the progress achieved since the last meeting of the Commission in Istanbul, Turkey in 2007 for the implementation of the MCSD programme as well as the relevant decisions of the meeting of the Contracting Parties, Almeria, 2008. The meeting is expected to generally discuss the thematic draft recommendations proposed by the different working expert groups.

<u>Expected outcome</u>: Achievements and challenges during the implementation of the MCSD programme of work discussed, and priorities highlighted. Draft thematic recommendations on tourism, agriculture and rural development issues reviewed and agreed for submission to the 16th contracting Parties meeting.

14.30-15.30 Agenda item 5: <u>Climate Change Adaptation Experiences and</u> <u>Strategies in the Mediterranean¹</u>

In order to give the members of the Commission the opportunity to discuss in greater detail and arrive at conclusions and make recommendations it is proposed to organize the discussion under two topics in plenary and breakout sessions. Presentations will be made to the plenary; while in depth discussion will be held in breakout groups. Each group will be facilitated by a person to be chosen among the group with support form the Secretariat. Conclusions and/or recommendations coming from the breakout groups will be discussed in plenary.

5.1 Current state of knowledge on adaptation to climate change and main issues to be addressed - Perspectives of key stakeholders

The following presentations will be made to the plenary:

a) Current state of knowledge: Climate Change in the Mediterranean region (Mr. Henri Luc Thibault Director of Blue Plan/RAC of MAP)

b) Challenges and responses to adaptation in the context of the NSSD – experiences and challenges from Egypt, Italy and Montenegro;

c) A civil society perspective, IUCN (Ms. Margarita Astralaga, Director of IUCN Centre for Mediterranean Cooperation);

d) A local level perspective (Mr. Emilio D'Alessio, President of Italian Local Agenda 21).

Questions and general remarks to be followed by discussion in groups

Groups will also highlight areas of capacity building needs.

<u>Expected outcome</u>: MCSD common understanding of climate vulnerabilities as well as priorities and lessons learnt from existing adaptation strategies and identification of priority actions at global, regional, national and local levels.

3) Trends in green energy - opportunities and challenges emerging from carbon markets and green Sate policies for the Mediterranean Sea and Coastal Ecosystems (Mr. Luis Constantino, Sector Manager for the Middle East and North Africa region responsible for climate change-related activities, World Bank)

4) Current and emerging priority programmes for Adaptation to climate change (Ms. Emily Massawa, Climate Change Adaptation Unit, UNEP)
