Introduction

The main objective of the meeting of the MAP Focal Points is to review the progress achieved during the 2010-2011 biennium, in the implementation of the programme of work and activities approved at the 16th Meeting of the Contracting Parties (Marrakesh, Morocco, November 2009). It will also review the draft Decisions and Programme of Work and Budget for the 2012-2013 biennium, with a view to their finalisation for submission to the 17th Meeting of the Contracting Parties in February 2012 for its consideration.

The following annotations to the proposed provisional agenda for the present meeting were prepared by the Secretariat to assist the meeting in its deliberations.

Agenda item 1: Opening of the meeting

The meeting will be opened at 9.00 a.m. on Monday, 28 November 2011 by the Executive Secretary and Coordinator of the Mediterranean Action Plan – Barcelona Convention.

Agenda item 2: Organizational matters

a) Rules of procedure for meeting of the MAP Focal Points

The rules of procedure for meetings and conferences of the Contracting Parties to the Convention for the Protection of the Marine Environment and the Coastal Region of the Mediterranean and its Protocols will apply *mutatis mutandis* to the present meeting (UNEP/IG.43/6, Annex XI).

b) Election of officers

Subject to Rule 20 of the rules of procedure mentioned at para. 2(a), the meeting of the MAP Focal Points shall elect from among the representatives of the Contracting Parties, a President, four Vice-Presidents and a Rapporteur.

c) Adoption of the Provisional Agenda

Subject to Rule 14 of the rules of procedure mentioned at para. 2(a), the proposed agenda appearing in document UNEP(DEPI)/MED WG 363/1 and annotated in the present document will be proposed for adoption by the meeting. The meeting will review and adopt the proposed timetable presented in the Annex to the present document (UNEP(DEPI)/MED WG 363/2).

The provisional agenda was prepared by the Secretariat in consultation with the Bureau of the Contracting Parties and the Executive Coordination Panel (ECP).

The Meeting of the MAP Focal Points may wish to decide to meet from 9.00 a.m. to 1 p.m. and from 2.30 p.m. to 6.00 pm, subject to adjustments as necessary. Ad hoc discussion groups or drafting sub committees may be formed by the meeting, if necessary, in consultation with the Secretariat.
