Introduction

- 1. The objectives of the meeting of the MAP Focal Points are to review the progress achieved during the 2014-2015 biennium in the implementation of the programme of work and activities approved COP 18 (Istanbul, Turkey, December 2013); and approve a number of thematic draft decisions for submission to COP 19, aiming at strengthening the implementation of the Barcelona Convention and its Protocols, as well as the proposed biannual Programme of Work (PoW) and Budget 2016-2017 prepared by the Secretariat.
- 2. As part of the package of draft decisions, the meeting of MAP Focal Points is expected to generally review and transmit to COP 19 for its consideration and possible adoption a number of strategic and programmatic documents such as MSSD, UNEP/MAP Mid-Term Strategy 2016-2021, and Action Plans.

The following annotations to the proposed provisional agenda for the present meeting were prepared by the Secretariat to assist the meeting in its deliberations.

- 8. Simultaneous interpretation in English and French will be available for the plenary sessions. Documentation will be in English and French. As per practice, pre-session documentation will not be distributed on paper. Participants are encouraged to download the documentation on their computers in advance of the session.
- 9. Sessions are scheduled every day from 09:30-12:30 and 14:30-17:30. Provisions have been made for evening sessions as need be during the first two days, subject to the decision by the meeting. The evening sessions may take place at 19:30-22:30. The morning of the last day of the meeting will be allocated for preparation of the Report of the Meeting and the afternoon session will take place between 14:30 and 17:30.
- 10. It is expected that the MAP Focal Points will address all items of the Agenda during its four-day meeting. It is envisaged to close the meeting at 17:30 on 16 October 2015 after adopting its draft Report.
