

INSTRUCTIONS TO AUTHORS

1 Submission of Articles

Articles may be sent to the Editor-in-Chief or to either of the Associate Editors.

Articles should be between 5000-8000 words, though the Journal can accommodate more substantial pieces. Authors are reminded that the Journal has an international circulation, and are therefore encouraged to ensure that the context of laws and policies are clearly explained (in footnotes, if appropriate) to readers who may be unfamiliar with the details of particular national systems.

Typescripts will not be returned unless special arrangements have been made to this effect. Articles submitted for publication must not be under consideration for publication elsewhere.

2 Preparation of articles

Three copies of each typescript must be submitted. The paper should be typed on one side only with double spacing on A4 (197×210 mm) paper or nearest equivalent. Pages must be in numbered sequence. The name of the author(s) should appear at the beginning immediately under the title, with an asterisked footnote giving the present position of the author(s) and an address for contact by readers, together with any desired acknowledgements.

3 Submission of Case Law Analysis

Analysis and judgments of significant case-law on environmental issues should be submitted direct to the Case-Law Editor, who welcomes prior discussion on potential material for inclusion in this section: Professor Michael Purdue, Faculty of Law, The University, Windsor Terrace, Newcastle upon Tyne NE_I 7RU.

4 Footnotes and references

Footnotes and references should be numbered consecutively and typed on separate sheets. Literature references should consist of the author's name and initials, year, title of book (followed by place of publication, name of publisher and page or chapter numbers) or paper (followed by title of journal, volume, and page numbers). The mode of citation of legal materials (legislation, case names, law reports etc.) employed in the system of origin of the article may be used.

Authors are responsible for checking the accuracy of all references.

5 Tables and illustrations

Tables should be typed, without vertical lines, on a separate sheet and the approximate position in the text indicated by a marginal note. Original graphs and line drawings must be submitted in a form ready for the printer. Diagrams must be drawn in black ink on a white or feint blue lined background.

6 Proofs

Authors will receive proofs of their articles for correction. No major changes are permissible at this stage and alterations should be restricted to correction of typographical errors.

7 Copyright/offprints

Authors submitting a paper do so on the understanding that, if accepted for publication, exclusive copyright in the paper shall be assigned to the publishers. In consideration for assignment of copyright, the publisher will supply the author with 30 offprints without covers of each paper. Further offprints may be ordered at extra cost when returning proofs.

The author will be free to use his material in subsequent publications written or edited by himself provided acknowledgement is made of the Journal as the place of original publication.

It is the author's responsibility to obtain permission to quote material from copyright sources.
