





### Climate change impacts Stern Commission

### Environmental refugees? Sea-level transgression scenarios for Bangladesh



Increased risk of floods, potentially displacing tens of millions of people, due to sea level rise and heavy rainfall events.

Bangladesh is projected to lose about 17% of its land area with a sea level rise of one meter - very difficult to adapt due to lack of adaptive capacity

"Climate change has contributed to the increase of both sudden-onset natural disasters and slow-onset events, and ... these events have adverse effects on the full enjoyment of all human rights."

## Most recent UN Human Rights Council Declaration on Human Rights and Climate Change June 30, 2015

"Emphasizes the urgent importance of continuing to address, as they relate to States' human rights obligations, the adverse consequences of climate change for all, particularly in developing countries and its people whose situation is most vulnerable to climate change, especially those in a situation of extreme poverty, and deteriorating livelihood conditions."

# Extraterritorial obligations relevant to climate change and human rights OHCHR 2009

- Refrain from interfering with enjoyment of human rights in other countries
- Prevent third parties (e.g. private companies)
   over which they hold influence from interfering
   with enjoyment of human rights in other
   countries
- International assistance: disaster relief, assistance to refugees and displaced persons
- Ensure that human rights are given due attention in international agreements
